1. Sl. No. 3 of Annexure-A to Corrigendum No. 1 dated 05.02.2024 stands revised as under:

Quote:

Administrative Office/ Plant in charge building shall be designed as per OISD STD 163 Clause no. 5.2. The building shall have one (01) Plant In-charge room, one (01) shift in-charge room, five (05) nos. discipline engineers' room, one (01) office assistant room on the first floor. Adequate nos. of separate gents' toilet and ladies toilet shall be considered in the building. Septic tank shall be designed for 15 persons.

The control room building shall be designed as per OISD-STD-163 and OISD-STD-118 on the ground floor. The size of the control room shall be adequate for integration of C&I system of future crude oil dehydration facility & formation water treatment & handling system.

Note:

Two separate RCC buildings shall be considered for the Office building and Control Room Building. The control room building shall be a single storied building. For Office building, EPMC to decide whether single or double storied depending on office accommodation requirements.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
